Based on Article 71 of the Law on Tourism of the Canton of Sarajevo ("Official Gazette of the Canton of Sarajevo", No. 19/16, 31/17, 34/17 and 13/21), Art. 30. Statute of the Tourist Board of Sarajevo Canton ("Official Gazette of Sarajevo Canton", number: 32/17), Subsidy Program for the Development of Tourism and Air Traffic in the Area of Sarajevo Canton (number 02-04-31542-47.1/23 dated 06.07.2023 No. 02-04-43008-1 /23 dated 05.10.2023), Public call for subsidizing air traffic in the area of Sarajevo Canton (1382-1/23 dated 13.10.2023), Minutes of the work of the Commission for expert evaluation of applications (938-25 /23 dated 22.09.2023), the President of the Tourist Board of the Canton of Sarajevo issues:

THE DECISION on the selection of airlines

Article 1.

The right to subsidize air traffic in the area of Sarajevo Canton after the Public Call was held by the following airlines:

1.RYANAIR DAC 2.SUNEXPRESS AIRLINES 3.WIZZ AIR HUNGARY LTD

and a contract has to be concluded with the same.

Article 2.

The decision enters into force on the day of its adoption.

Rationale

The Committee for Expert Evaluation of Applications determined in the minutes after considering the applications received under the Public Call that five timely applications were received, while one application was received after the deadline and was not subject to consideration. The Commission unanimously stated that the companies: RYANAIR DAC, SUNEXPRESS AIRLINES and WIZZ AIR HUNGARY LTD have submitted the documentation requested by the Public Invitation. The Commission stated that the company POLSKIE LINIE LOTNICZE "LOT" S.A. partially satisfies the conditions required by the Public Invitation, in the way that it submitted documentation for points 1,2,3,5,6,7 and 8, but no documentation was submitted for point 4. and that

she did not fulfill the conditions of the Public Call. Also, the commission stated that the application of the company TUI AIRWAYS in terms of the period of operation is not in accordance with the subject and purpose of the Public Call and that it did not fulfill the conditions of the Public Call. The Commission unanimously stated that one application was received outside the deadline for applications from the company NORWEGIAN AIR and that it was not taken into consideration.

Considering the above, a decision was made as in the enacting clause.
